- E) Both Parties, being legal entities in themselves desire to sign this MoU for advancing their mutualinterests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MoU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1

CO-OPERATION

Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the Institution and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for oneanother.

CLAUSE 2

SCOPE OF THE MOU

- 2.1 The budding graduates from the institutions could play a key role in technological upgradation, innovation and competitiveness of an industry. Both parties relieve that close co-operation between the two would be of major benefit to the student community to enhance their skills andknowledge.
- 2.2 Technical Training: Second Party will provide valuable trainings to the First Party on modern and latest technology and suitably customize the curriculum so that the students fit into the industrial scenariomeaningfully. Industry and Institution interaction will give an insight to the latest developments/requirements of the industries. The

industrial training and exposure provided to students will build confidence and prepare the

students to have a smooth transition from academic to working career.

- 2.3 Skill Development Programs: Second Party to train the students of First Party on the soft skills in order to bridge the skill gap and make them industry ready.
- 2.4 Guest Lectures: Second Party to extend the necessary support to deliver guest lecturers to the students of the First Party on the technology trends and in house requirements.
- 2.5 Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programmes on the terms specified herein.
- 2.6 Thereisnofinancialcommitmentonthepartofthis MOU, both the parties will mutually decide on the financials of any programme to be conducted on case to case basis.

CLAUSE 3

VAI IDITY

- 4.1 This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms.
- 4.2 Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of termination, both parties have to discharge theirobligations

CLAUSE 4

RELATIONSHIP BETWEEN THE PARTIES

It is expressly agreed that First Party and Second Party are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in

any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties under the jurisdiction of Kolkata.
