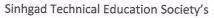

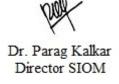

- 1. All grievances would be redressed in a systematic way by involving the respective department/person directly connected to the specific issue & severity.
- 2. The previously framed Students Grievance redressal system to be followed systematically.
- 3. The institute should emphasize on prevention of misconduct rather than controlling through punitive measures, hence proper code of conduct for students should be communicated during the induction by class coordinators.
- 4. All class coordinators and mentors are instructed to have periodical discussions with the students in order to understand, if there are any issues that need to be addressed.
- 5. In the discussion, it was decided to forward the complaint to the admin department. In this regards, oral communication with admin officer was made by member.
- 6. Admin officer has increased the number of tubes for sufficient light in the classroom. All other grievances were redressed and necessary action was taken.
